Dear Geshe;

Thank you for agreeing to bring the Great Compassion Mandala Tour to the Bellevue Botanical Garden September 14 -16, 2018. This letter confirms details of the tour and arrangements agreed to.

Six monks will be on site and creating the mandala in the Short's House here at the Bellevue Botanical Garden. The project is expected to last 3 days.

Important things to note:

- The fee for this tour stop is \$3,000, and will be paid upon commencement of the mandala project here at the Bellevue Botanical Garden. This fee is to help cover the expense of the tour and will be paid to the Siddhartha School Project USA for the Great Compassion Mandala Tour.
- The Bellevue Botanical Garden will arrange to provide housing and food for the six monks while they are at Bellevue Botanical Garden. Please provide exact dates housing is needed at your earliest convenience.
- Per our agreement, the Siddhartha School Project and Ngari Institute will not be allowed to collect donations at the Bellevue Botanical Garden yet there can be materials and activity on site educating and informing the public about Himalayan Buddhist culture and arts.
- The Short's House will be open and unlocked from 7:00am to 4:00pm. The Bellevue Botanical Garden will provide tables for the mandala and cushions for the monks. Please provide specifics such as height and diameter at your earliest convenience.
- As part of the agreement there is a liability waiver which needs to be signed and returned with this agreement.
